4. You will ensure compliance with other provisions of the Act and the listing Agreement as applicable to you as an Independent Director

B. Term

Your Appointment is for a term as specified at the time of appointment, subject to approval of shareholders in the ensuing Annual General Meeting of the Company.

C. Committees
